Notes from the meeting:

- An overview was given of Xcel's Colorado Power Pathway project
- A slide show presented specific facts about the project, concerns of the group, and an organizational model (click here for slides)
- The name Elbert County Environmental Alliance was adopted with the mission of protecting our community by minimizing the environmental and economic degradation from Segment 5 of the Colorado Power Pathway in Elbert County. Specific objectives include:
 - Maintain healthy lifestyles for our families
 - Protect wildlife
 - Protect our local economy
 - Protect the beauty of our county
 - Protect the historic Bijou Basin
 - Maintain property values
 - Limit the spread of big city resource requirements being built within our small county
- Commissioner Thayer shared his discussion with and Xcel representative (Tom Henley) and lobbyist (Greg Brophy)
 - o wind and solar farms tend to be built within 500 feet of transmission lines
 - Fire mitigation is a big issue
 - Residents are able to speak at County Commissioner meetings during the public comment section (2nd and 4th Wednesdays)
- Contact has been made with the Department of Wildlife
 - o Bijou Basin is most pristine area. Filled with wildlife
 - There are many waterways within the proposed route
 - Lines will interfere with animal migration patterns
 - o Federal subsidies are involved check into rules and regulations
 - Research alternatives with current infrastructure
 - Have commissioners call for public meetings
- Xcel has planned upcoming "Open Houses" (<u>click here</u> for schedule of events). Revised routes will be available then.
 - o The first open house will be in Platteville on Jan. 24
 - The Kiowa open house will be March 1st
- Subcommittees were formed:
 - o Membership generate new members, community outreach
 - o Communication- website, newsletters, social media, local media

- o Research-track Xcel plan and PUC, identify environmental impacts, fact checking
- Operations-events, lobby, tasks, alternatives
- Logistics-fundraisers, flyers, signs, coordinate meetings
